RETURN SERVICE COMMITMENT					
I understand that every student selected to receive a Partnerships Bursary must sign a return service contract which commits the student to live and work in northern Alberta upon graduation. Return service is one full-time month of employment (or equivalent) for each \$500 of total bursary support, for example: 12 full-time months for a combined \$6,000 bursary. Alberta Advanced Education will sign a contract with all bursary recipients. Sponsors may also sign a contract with the student for employment with the sponsor.
